CONSTRUCTION OF HAY BARNS IN KAJIADO AND NAROK COUNTY

Neighbours Initiative Alliance (NIA) is a Non-governmental organization working with pastoralists communities in Kenya. It was established and registered in 1996 as a non-profit making organization under the NGO coordination Act.

Funded by The Federal Ministry for Economic Cooperation (BMZ) and in partnership with Welthungerhilfe (WHH), NIA invites potential suppliers to submit bids for **construction of 3000 bales capacity hay barns** as described in the attached BOQ/Tender Submission Form.

Eligible firms are requested to submit their bids in sealed envelopes addressed as follows;

Delivery options: a) Courier services, Post Box Office and physical deposits into the Tender Box at NIA offices in Kajiado along Athi River-Namanga highway next to Kajiado Police Station. All bids to be received not later than **18**Th **December, 2018 at 11am**. The opening of the tender documents will be held at 11.00 a.m. on 20Th December, 2018.


Quotations to be submitted on the standard Tender Submission Form cum BOQ attached herein.

1. General remarks and special condition

The hay barn should carry a capacity of 3000 bales with the following outline/design and measurements.

Sketch Plan for 3000 bales capacity hay barn/store

Length BC- 48ft Width AB- 16ft Height CD-14ft



Materials

A) Roof

- -Corrugated iron sheet 3m- 36 pcs
- -Roofing nails-11 kgs
- -Ridges-8 pcs

B) Walls

- -3 by 3 (75mm by 75mm by 3mm thickness square3 iron.
- -Wire mesh.
- -2 doors(inlet and outlet for hay bales)
- C) Floor
- -Concrete floor.

• The hay barns should store 3000 bales.

- The hay barns will be constructed in Kajiado central sub-counties and also in Narok west and south sub counties.
- <u>Single construction firm is preferred.</u> However, NIA/WHH reserves the right to divide the order into lots and award per lot to various bidders.
- Total of 10 hay barns will be built; 5 in Kajiado and 5 in Narok.

2. Specifications / Quantities

The detailed specifications of the hay barn design is as per above design and materials indicated in the BOQ.

3. Start and completion

If contract is awarded, construction of hay barns should begin immediately and to be completed in 7 weeks from the signing of the contract.

4 Prices

The quotations should be stated in Kenyan currency only those stated otherwise will not be considered in the awarding process. Prices must include all possible charges/taxes.

5. Tender fees

The tender document will be accessible on-line free of charge through the following weblink https://www.welthungerhilfe.org/tenders/, and will also be available at WHH/GAA Country office Nairobi in hard copy.

Alternatively, the tender documents can also be collected in hard copy at Neighbours Initiative Alliance Kajiado office in Kajiado, next to Kajiado police station **or** Neighbours Initiative Alliance **Narok field** office at Senators building (FGCK).

7. Tax Compliance

Bidders must also include the following in their bid envelopes:

- Copy of PIN certificate,
- Copy of VAT registration certificate
- Copy of the current Tax compliance certificate
- Copy of Kenya construction authority certificate.
- Profile on past experience.

Neighbours Initiative Alliance will do inspection and approval of constructed hay barns.

12. Tender submission form & requirements

Following documents must be submitted before tender closing:

- Quotation in sealed envelopes (marked only with the tender reference) to be dropped at WHH/GAA
 Country office Nairobi Tender box or Neighbours Initiative Alliance tender box in Kajiado office or sent
 through the addresses provided above.
- Tender to be filled in the standard **Tender Submission Form** (attached). The tender submission form to be stamped and signed by the bidder indicating the name and contact details.
- The Supplier Prequalification document (3 pages, attached to this tender), must be filled and attached to the tender submission form.
- Tax compliance documents as listed under no. 7 above.

Important Note: Tenders missing any of the above requirements shall be rejected as incomplete.

13. Payment Conditions

Cash against documents (CAD). Payment within 10 working days upon receipt of the following documents:

- Original Invoice on the supplier's letterhead.
- Completion certificate or Approval of the hay barns constructed.

14. Evaluation and qualification criteria

- We prefer one single construction firm but reserve the right to divide the order based on our internal evaluation.
- Suppliers not providing all necessary documents, properly signed and stamped will be excluded.
- The deadline for the submission of the requirements is firm and non–negotiable. Late documentation or offers will not be taken into consideration.

The following criteria will be considered in the evaluation and contract granting:

- 60% in total amount i.e. Total quoted amount for construction of one hay barn as per the BOQ.
- 30% past experience on constructions of hay barn structures or equivalent.
- 10% completeness of tender document and conformity with the specifications and tender requirements.

15. Tender Conditions

The tender must be valid for 21 days from the tender deadline.

Quotations must specify all details according to the tender text. Incomplete offers and offers that arrive later than the deadline for reply will be automatically be excluded. All responses will be opened by the WHH/NIA tender committee only. Bidders who do not receive a written feedback **21** days after expiry of the deadline should consider themselves unsuccessful.

16. Tender deadline

Deadline of submission shall be **Tuesday 18th December, 2018 at 11:00 AM**

The tender is valid without original signature as well.
